



RELEASE OF LIABILITY AND WAIVER OF CLAIMS

The Barn/Barn Archers refers also to the owners Bridget Benz and Joe MacHoll

In consideration for being permitted to use “The Barn” owned by Bridget Benz and Joe MacHoll archery hall and outdoor course I agree as follows:

1. I am aware that use of this archery indoor shooting barn and outdoor course, to participate in the sport of archery and the activities, programs, classes and services provided by, and/or in the events sponsored or organized by The Barn or Barn Archers is entirely at my own risk. I freely accept and fully assume all risks, dangers and hazards resulting from my use of The Barn and the outdoor course.
2. I acknowledge that I am voluntarily consenting to the use of the Barn and outdoor course and that; by doing so, I am voluntarily assuming all risks of injury or death or damage which I may suffer as a result of my use of the Barn and the outdoor course.
3. The COVID-19 disease has been declared a worldwide pandemic by the World Health Organization and is contagious. The Barn cannot guarantee that I will not become infected with COVID-19.
Further, participating in the activities could increase my risk of contracting COVID-19.
4. I agree to release and hold harmless the owners of the Barn Bridget Benz and Joe MacHoll as well as their respective employees, volunteers, contractors and agents from any and all liability for any loss, damage, injury and expense that I may suffer as a result of my use of the Barn indoor archery shooting range and outdoor shooting course.
5. I am aware of, and agree to follow, the Barn Rules and Code of Conduct associated with the appropriate use of the Barn and outdoor course. [View Barn Rules and Code of Conduct].
6. **PARENT CONSENT.** I, the minor's parent and/or legal guardian, understand the nature of the above referenced activities and the minor's experience and capabilities and believe the minor to be qualified to participate in such activity. I hereby release, discharge, covenant not to sue, and AGREE TO INDEMNIFY AND SAVE AND HOLD HARMLESS all persons listed in paragraph 4 above (hereinafter referred to as “those listed persons”) from all liability, claims, demands, losses, or damages or on the minor's account caused or alleged to have been caused in whole or in part by the negligence of or otherwise, including negligent rescue operations, and further agree-that if, despite this release, I, the minor, or anyone on the minor's behalf makes a claim against any of those listed persons, I WILL INDEMNIFY, SAVE AND HOLD HARMLESS each of the RELEASES from any litigation expenses, attorney fees, loss liability; damage, or cost any RELEASES many incur as the result of any such claim.
7. **PERMISSION FOR PHOTOGRAPHY.** I grant to The Barn the absolute and irrevocable right and unrestricted permission concerning any photographs that The Barn has taken or may take of me or in which I may be included with others, to use, reuse, publish, and republish the photographs in whole or in part, individually or in connection with other material in any and all media now or hereafter known; including the internet, and for any purpose whatsoever, specifically including, promotion, art, editorial advertising, and trade, without restriction as to alteration; and to use my name in connection with any use if he/she so chooses. I release and discharge The Barn from any and all claims and demands that may arise out afar in connection with the use of the photographs including without limitation any and all claims for libel or violation of any right of publicity or privacy. This authorization and release shall also inure to the benefit of the heirs, Legal representatives, licensees; and assigns of Photographer, as well as the person(s) for whom he/she took the photographs. I am a legally competent adult and have the right to contract in my own name.

I have read this document and fully understand its contents. This release shall be binding upon me and my heirs, legal representatives, and assigns.

Code of Ethics

1. As Archers, we will respect the full due of all others in matters of their normal social rights and privileges, their privacy, and their property.
2. As Archers, we will respect the rules of safety applicable to our sport. Furthermore, we will most highly respect both the laws written to prescribe its legal pursuit and those usages, written or unwritten.
3. As Archers, we will respect our worldly environment, persistently seeking to maintain or improve its established ecology.
4. As Archers, we will respect the need for such ethical conduct among the young or the uninitiated and will endeavour to pass onto others all the skills, attitudes, and knowledge essential to good sportsmanship.



SAFETY RULES

- > Be aware of your surroundings. Use your brain.
- > Youth under 18 must be accompanied by an adult.
- > Stand with your feet just behind the shooting line while shooting.
- > Do not shoot diagonally across the range towards a target. No high draws.
- > Always draw the bow pointed toward the target, with or without arrows.
- > Never dry-fire a bow (let go of the string without an arrow being nocked).
- > Wait behind the shooting line until all archers are finished shooting and the signal **'ALL CLEAR'** to collect is given.
- > Be respectful of shooters on the shooting line.
- > Be respectful of other archer's equipment and never handle another archer's equipment without permission.
- > Three arrows is the standard number for an end, if time permits more may be shot but do not hold up other shooters
- > You must clean up after yourself - pick up all debris.
- > Unauthorized use of the Barn is not permitted.
- > When using Barn equipment, respect it and treat it as if it was your own.
- > You must follow the range officer's instructions.
- > Be patient with those teaching beginners and beginners shooting on their own. We all started somewhere!
- > Use the barn at your own risk.
